2010 Photography Trip – Release of Liability and Personal Responsibility

It is important that all Tour participants have the same understanding of the Coordinators role. Please read and sign this page.

Ric Kessler and Tom Isgar (The Coordinators) have agreed to coordinate certain arrangements for a photography Trip for the mutual benefit of a group of friends and acquaintances, and to act as the escrow agent to collect, assemble, and disburse certain funds in connections with the group's trip. By combining the funds in this manner the group will obtain discounted group airfares and special group concessions.

I, the below signed, understand and agree that:

A. The Coordinators are not acting as anything other than escrow agents to collect and disburse funds. They are not acting as travel agents, group travel advisors, travel escorts, photo escorts, or photography instructors.

B. The Coordinators have no-responsibility for determining my fitness to engage in physical activities in connection with the trip. It is my responsibility to do so. Physical activity is generally limited to walking to/from rooms to the loading areas with gear (I may request assistance at my expense), walking around the lodging areas, getting in and out of vehicles and conducting my photography activity.

C. The Coordinators will do everything they can to insure a safe trip but it is my responsibility to learn about and understand the risks inherent in travel and the risks inherent in a Trip. I assume all risks involved in such activities.

D. The Coordinators reserve the right to modify and/or cancel arrangements if unfavorable conditions arise and to substitute comparable facilities and equipment where possible. The remoteness of some areas, local customs and prevailing weather conditions may cause inconveniences or modifications to the program itinerary.

E. The coordinators have made arrangements with a variety of local contractors, airlines, lodges, and drivers. Each of these entities is a private contractor, and the Coordinators are not liable for and do not have control over the timeliness, quality, attitudes or rules associated with the delivery of said services. Efforts have been made to retain the best providers.

F. The Coordinators are not responsible for the behaviors, personalities or attitudes of other Trip participants.

G. The Coordinators may make additional reasonable terms and regulations during the course of the Trip to facilitate the trip with which I agree to comply.

H. Trip Insurance and trip health insurance are required for my protection.

I. The Coordinators reserve the right to deny any application for any reason whatsoever.

J. The Coordinators only liability or legal responsibility in this endeavor is to faithfully transmit the moneys entrusted to them as escrow agents to the appropriate entities. In consideration of being allowed to participate in the trip and activities that may be available during the trip, I agree to release, and absolve The Coordinators from any and all liability and responsibility for personal injury, property loss, death and any and all other damages that I might sustain in connection with or arising out of my participation in the trip.

K. Arbitration: Any controversy or claim arising out of or relating to this Agreement or the performance hereunder, including without limitation any claim related to bodily injury, property damage or death, shall be settled by binding arbitration in Sarasota, Florida in accordance with the rules of the American Arbitration Association and the laws of the State of Florida.
